

During the Month of April 2013, Detectives from the Stratford Police Narcotics Vice and Intelligence Unit began an investigation into the activities of Ronald Marcellus D.O.B 02/09/1970 AKA "FATS". Through that investigation, detectives learned that Marcellus was selling crack cocaine within the Town of Stratford and surrounding communities. Sometime there after, Detectives obtained a search warrant for several locations associated with Marcellus and his operation, in addition to an arrest warrant for Marcellus.

During the Month of June 2013, Detectives with the Stratford Police Narcotics Vice and Intelligence Unit, with assistance from the Bridgeport Police ESU Unit, DEA BRO, and New Haven Police, executed the above mention Search and arrest warrants. At that time, Marcellus was taken into custody and charged as follows: Operating a Drug Factory CGS 21a-277(c), Poss. WITS Crack/Cocaine CGS 21a-278(b), Criminal Possession of a Firearm CGS 53a-217, Altering a Firearm CGS 29-36, Theft of a Firearm C.G.S 53a-212 and (3) Counts of Sales of Narcotics CGS 21a-278(b). At that time, Marcellus was issued a \$350,000 which he posted and was released.

Shortly thereafter, Detectives from the Stratford Police Narcotics Vice and Intelligence Unit discovered that Marcellus was arrested by State Police for Possession WITS Narcotics C.G.S 21a-278(b). Marcellus was able to post his \$75,000 bond and was released from custody.

Shortly after Marcellus' arrest by State Police, Detectives from the Stratford Police Narcotics Vice and Intelligence Unit began looking into the activities of Marcellus once again. Through their investigation, Detectives learned that Marcellus was again selling Crack Cocaine within the Town of Stratford and surrounding communities. Detectives secured an arrest warrant for Marcellus for Sales of Narcotics.

On 08/16/2013, Detectives from the Stratford Police Narcotics Vice and Intelligence Unit along with assistance from the Bridgeport Police Department Detective Bureau, conducted a MV stop on Marcellus. Marcellus was taken into custody without incident. Inside Marcellus' vehicle, Detectives discovered 9.4 grams of Crack Cocaine packaged for street sale along with U.S Currency that is suspected drug proceeds.

Marcellus was transported to headquarters and charged as follows:

Two Counts of Sale of Narcotics C.G.S 21a-278(b) and Two Counts of Sale of Narcotics within 1500' of a School C.G.S 21a-278a(b). Marcellus was issued a Court Set Bond of \$700,000 which he was unable to post. Marcellus was given a court date of 08/23/2013.

Marcellus was additionally charged with Possession WITS Narcotics C.G.S 21a-278(b), Possession of Narcotics C.G.S 21a-279(a) and Violation of Conditions of Release C.G.S 53a-222. Marcellus was given a \$300,000 bond for these charges which he was unable to post. Marcellus was given 08/23/2013 for a Court date.
